INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF VARIOUS GOODS


1. The PNP ACG Bids and Awards Committee (PNP ACG BAC) through RA Nr. 11936 dated December 26, 2022 otherwise known as the General Appropriation Act (GAA) for Fiscal Year (FY) 2023 and Trust Receipts intends to apply for public bidding on the following:

2. Bidding shall be conducted through open competitive bidding using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of the Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
3. Bidding is restricted to Filipino Citizens sole proprietorship/partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. The complete set of Bidding Documents may be acquired by Interested Bidders on **December 28, 2023**, onward, from 8:00 AM to 5:00 PM except Saturdays, Sundays and Holidays on the address stated upon payment of a non-refundable fee for the Bidding Documents.
5. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the website of the Procuring Entity at <https://acg.pnp.gov.ph/main/procurement> provided that the Bidders shall pay the non-refundable fee for the Bidding Documents not later than the date of submission of bids.
6. Bid Opening is on **January 15, 2024 (Monday) at 2:00 PM** at PNP ACG Conference Room, 3rd Floor PNP ACG Building, Camp BGen Rafael T Crame, Quezon City. Bids shall be opened in the presence of the bidder's authorized representatives who will attend at the said activity at the address provided above. Late bids shall not be accepted.

7. The PNP ACG-BAC reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
