- Bidding is restricted to Filipino Citizens sole proprietorship/partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of

a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. The complete set of Bidding Documents may be acquired by Interested Bidders on **July 8, 2025**, onward, from 8:00 AM to 5:00 PM except Saturdays, Sundays and Holidays on the address stated upon payment of a non-refundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the website of the Procuring Entity at <https://acg.pnp.gov.ph/main/procurement> provided that the Bidders shall pay the non-refundable fee for the Bidding Documents not later than the date of submission of bids.

Bids shall be opened in the presence of the bidder's authorized representatives who will attend at the said activity at the address provided above. Late bids shall not be accepted.
